On April 27, 2024, Milford Police responded to the Holiday Inn Express located at 278 Old Gate Lane for a possible “shots fired” call. Upon arrival, a black sedan being operated by Johnson-Charles struck a police cruiser and took off at a high rate of speed. Officers pursued the vehicle before it eventually stopped on Old Gate Lane. Johnson-Charles was taken into custody without further incident. Investigation revealed that a group was shooting at each other with gel blaster toy guns. Infractions were also issued for creating a public disturbance.
