2006: Twenty (20) total lead-related recalls



<b>Date</b>	<b>Product</b>	<b>Message</b>
February 3, 2011	Stay of Enforcement	Starting on December 31, 2011, manufacturers and importers of children's products that are subject to the lead content limit must have the appropriate certificates that indicate that their products have been tested by a CPSC-approved third party laboratory, in order for their products to be sold in the United States.

April 13, 2011	Girl's Clothing Recalled by My Michelle	<p data-bbox="500 254 1481 415">This recall involves girl's tops and dresses sold in sizes small to extra-large and 7 to 16. The garments were sold in various styles including: tops with beaded necklaces attached to the collar and tops with metallic beads attached to the collar. All styles of the tops and dresses have a black tag on the collar with pink print that reads "mymichelle."</p> <div data-bbox="505 453 1390 1743">  <p>The images show a variety of garments: a white lace dress with a beaded necklace; a light blue cardigan over a white top with a beaded necklace; a floral dress with a black top and a beaded necklace; a floral skirt; a striped cardigan over a white top; a green ruffled top over a white dress; a blue top with a white lace collar; and a white top with a purple patterned scarf and a beaded necklace.</p> </div>

May 11, 2011	Toy Story 3 Bowling Game Due	<p>This recall affects Toy Story 3 Bowling Game Rugs with a batch marking of JA 148. The recalled item contains six white plastic bowling pins with two red stripes painted on the necks, one black plastic ball, and a 68 inch x 26 inch nylon game rug with a print of the character Buzz Lightyear on the front. The batch marking JA 148 appears on the bottom front of the packaging just above the bar code, and is also located on the tag attached to the rug.</p> <div style="text-align: center;">  <p>RED PAINT</p> </div> <div style="text-align: center;">  </div>

June 8, 2011	American Girl Crafts Jewelry Kit	<p>This recall involves the Pearly Beads &amp; Ribbon Bracelets kit distributed under the American Girl Crafts name with a SKU number of 30-585331. The SKU number is located on the back of the package in the lower right corner. The kit contains 56 pieces. The beads in the jewelry kit are pink, blue, orange and white. Some pink beads have darker pink butterflies imprinted on them. The ribbons in the kit are orange, red, blue and purple.</p>

July 5, 2011	Children's Tennis Racquets	<p data-bbox="451 254 1438 348">This recall involves Quick Kids 23-inch aluminum junior tennis racquets with orange tape on the hand grip. Recalled racquets have lot number "F:3:10:08" stamped onto the bottom of the racquet grip below the "G."</p> <div data-bbox="451 384 699 1171"></div> <div data-bbox="837 495 1490 1083"></div> <p data-bbox="792 1150 1398 1182">Lot number is stamped on bottom of racquet</p>

July 5, 2011	Wooden Animal Drum	<p data-bbox="500 247 1487 317">The recalled toy is a wooden hexagon drum with pictures of animals on the six sides. SKU No. 424857 is printed on a sticker on the bottom of the drum.</p>  A photograph of a wooden hexagonal drum. The top surface is light-colored wood with two black outlines of drumsticks. The sides are painted in different colors: one side is purple with a butterfly illustration, and another side is red with a monkey illustration. The drum is shown from a three-quarter perspective.

July 5, 2011	CPSC Announcement	Starting on August 14, 2011, manufacturers, importers, retailers and distributors of children's products must comply with the new 100 ppm federal limit for total lead content. CPSC will not enforce the CPSIA's independent third party testing requirement for total lead content until December 31, 2011, due to a stay of enforcement that is already in place.

August 5, 2011	Build-A-Bear Workshop Lapel Pins	<p>This recall involves a 1.5 inch lapel pin features graphics of a heart, bear head, and peace sign all positioned in front of a globe. The words "Love.Hugs.Peace." appear at the bottom of the pin.</p>  A circular lapel pin with a gold-colored border. The central design is a globe with green continents and blue oceans. Overlaid on the globe are three circular icons: a red heart at the top, a brown bear head at the bottom left, and a blue peace sign at the bottom right. At the bottom of the pin, the words "Love Hugs Peace" are written in a gold, cursive font.

September 29, 2011	Toy Cars	<p>The products are sold in packages of four or six toy cars which are painted in silver, black or blue with red stickers with “super,” “max” and “racing” labeled on the top and sides of the cars. The 4” plastic car sets have item numbers “43835” and “43836” printed on a white label on the back of the cardboard packaging. “Gallop X” or “RACING CARS” is also printed on the product packaging.</p>

December 22, 2011	Children's Travel Cases	<p>The Circo brand label is found on the fabric handle attached to the top of the travel case. The girls' version has a heart/butterfly/daisy pattern on either a pink or teal background with a plush butterfly attached to the zipper pull. The boys' version has a pattern of three jet planes in red/blue/green on a red or blue airplane-patterned background with a blue plush jet plane attached to the zipper pull.
