

**BOARD OF ALDERMEN  
REGULAR MEETING  
JANUARY 4, 2010**

The Board of Aldermen of the City of Milford held their Regular Meeting on Monday, January 4, 2010 in the aldermanic chambers of City Hall. Chairman G. Smith called the meeting to order at 7:56 p.m. extending a Happy New Year to all. Chairman Smith asked those present to join in saluting our flag and reciting the Pledge of Allegiance.

2. Public Statements

Public statements are limited to the legislative function of the Board of Aldermen. He stated only residents; taxpayers or electors may address the Board. The time limit granted to each speaker shall be three (3) minutes. He asked each speaker to adhere to the three-minute limit.

T. Chaucer – 104 Hawley Avenue – provided the Board of Aldermen with a packet of information regarding the Downs House. He went on to explain the map and other handouts in the packet. He stated the Downs House gives the City great character. He also stated it should be open to the public. He went on with a lengthy history of those prominent individuals who are linked to Milford's history in addition to John Downs, such as Nathan Hale, Joseph Plumb Martin, and others who have such valuable links to Milford.

R. Platt – 132 Platt Street – wished the Board a Happy New Year. He also thanked Mr. Chaucer for the history lesson and stated he was in support of his idea for the Downs House. Mr. Platt stated the Downs House was saved from demolition by neglect. He stated with regard to the house that the interior has been gutted, but you can still see in great detail how the 18<sup>th</sup> Century house was put together. He stated he was also in support of the modification to the demolition delay Ordinance, which eliminates the 50% and that he was happy after his strong pleas that this was finally before the Board. He expressed his hope it would be passed tonight.

J. Prisco – 11 Riverdale Road – stated he was speaking tonight regarding Pumpkin Delight School and the need for an elevator in that school. He stated it is the only elementary school in Milford with two floors. He stated he hoped this Board would approve an elevator for the school. He spoke as to State funds which might help. He also mentioned the Devon project and how long it has taken. He asked the Board to please think of the kids.

G. Salvatore – 17 Saint Andrews Lane – stated she wished to speak concerning two issues. The first regarding blight as it has been called, previously called by the EDC, neighborhood preservation. She expressed her concern over the 50 individual complaints of properties have been received that need attention. She stated if people take the time to notify the City that they should be kept in the process. Ms. Salvatore stated once a person has made a complaint they don't get a response because that office is overwhelmed. She stated she was here to ask this Board to consider a review of the blight Ordinance to keep the citizens involved in the process and that the City owed that to them. She stated the second reason for speaking was to state her support of the revision of the Demolition Delay Ordinance. She stated it is a step in the right direction and also in keeping the character of the City intact. She stated it was important to keep our foundation from crumbling so that the character is not lost. She concluded by stating to have a future you have to preserve the past.

T. Beirne – 55 Bayshore Drive – he stated he along with the late Walter Farley were on the Board when the original Demolition Delay Ordinance was passed and told of a story about what happened to properties at Fort Trumbull beach that became condominiums. He stated that would not have happened and this Ordinance could improve by having an enforcement officer. He stated the problem with the Ordinance is no one is overseeing it and suggested the City Historian be appointed as the enforcement officer.

B. Genovese – 19 Belmont Street – wished the Board a Happy New Year. She thanked the Board for passing the amendment to the Demolition Delay Ordinance. Regarding from a prepared statement regarding the Downs House, she stated the current administration would like to knock it down. She continued reading stating this administration needed to stop the destruction of our history. She asked the Board to always do their homework especially when dealing with historical properties and consider all the facts.

C. Martin – 14 Roswell Street – stated she wished to address Milford and the Board of Aldermen regarding a safety issue regarding the West Shore Fire Department, which is located in her backyard. She stated her concern is with the aerial ladder and her air rights which are being violated. She read the definition of air rights. She stated when the ladder is tested it extends onto her property and that it is trespassing as well as a safety issue. She stated this department does not have any concern for her house or her property. She stated that they recently violated her air space on December 23, 2009 and that the lieutenant on duty that day had no regard for the angle of her yard. Ms. Martin stated she has done her research with regard to aerial ladder injuries and that it is something that should not be taken lightly. She stated she has serious concerns and stated she hoped the Aldermen would take this into consideration and look into it.

K. Bonetti – 157 Seaside Avenue – stated she was speaking tonight regarding someone that is missing, the MGAT camera man. She stated there is one name they can all call friend and it is Dennis Guaglianone. Ms. Bonetti stated he is everywhere in Milford all year round and that he is all things Milford. She stated he has taken MGAT to incredible heights. She also pointed out he recently was awarded a partnership award from the Milford Board of Education for his work. She also stated his broadcasts have been live and if you missed it you would have the opportunity to see it later. She addressed his recent firing as being political and stated he is the

last person you would think of in that way. She stated he simply does what he is asked and then some. She expressed her hope the Board would be able to re-instate him.

J. Dellamonica, Sr. – 60 Berner Terrace – wished the Board a Happy New Year. He stated the Board of Aldermen opens each meeting with the pledge to our flag. He stated he would like to see the Board consider 15 seconds of silence for our men and women who are dying for us in the service. He asked the Board to think about all the things happening without our freedom and that we would have nothing. He asked the Board to please acknowledge these men and women by a brief moment of silence.

City Clerk Linda Stock administered the Oath of Office to those present.

8b. Ald. P. Smith and Ald. Patterson made and seconded a motion to approve the request to authorize the Public Works Director and the Purchasing Agent to dispose of obsolete and unusable equipment as listed on the memo from Public Works Director Bruce C. Kolwicz dated December 28, 2009.

Ald. Blake commented he understood this would be advertised in the legal notices, but that not that many people read that section. He asked if it had been investigated to use sources such as e-bay, Craig's list or the like to get a better rate.

Mayor Richetelli explained for many years this has been the method and that the request comes before this Board in a very transparent way. He stated the items are available for the Board's inspection. He also stated they follow the applicable laws. He stated the City does not have the availability to use e-bay or Craig's list and questioned if Ald. Blake were asking the City pay someone to investigate this. He stated many times these items end up scrapped, adding this equipment has been used and reused and there is not much value.

Ald. Staneski stated in follow up to Ald. Blake's comments, she would suggest these items be posted on the notice and on Channel 79 and then the citizens could see it.

Ald. G. Smith added these items part of the agenda. He stated he agreed with Ald. Blake that other options be looked at for the future.

Ald. Goodrich suggested the items be posted on the City's web-site.

Ald. P. Smith stated when looking at other alternatives they needed to keep in mind there is sometimes a fee involved.

Ald. Blake stated they may find e-bay or Craig's list is not the right fit, but it could be experimental to see how it goes and there certainly would be no harm in trying.

Motion carried unanimously.

8c. Ald. P. Smith and Ald. Goodrich made and seconded a motion to approve the request for an emergency waiver of bid to repair the heating system at Fire Headquarters to E.N.T. Heating and Cooling, Wallingford, CT, in an amount of \$12,500 per memo from Battalion Chief William D. Healey dated December 24, 2009.

Chairman G. Smith recognized Chief LaVecchia.



Chief LaVecchia stated he wanted the Board to know he takes the bidding process very seriously and that in his 14 years as Chief, the department has brought possibly four waivers to bids to this Board. He stated the repair was for the boiler at fire headquarters. He explained the boiler is in sections and that they tried to patch it, but it did not hold. He went on to explain the prices. He stated they have determined to go with a repair while they look for funding possibly through a block grant and that they have contacted Tom Ivers for his assistance with this. Chief LaVecchia stated he also contacted the City's purchasing agent and was told E.N.T. holds a contract with the City.

Ald. Veccharelli spoke at length regarding the monies. He stated he understood the monies were being used from building repairs but noted it would wipe out the entire account. He asked what would happen if there were other emergencies.

Chief LaVecchia compared this amount to that of a transmission or pump. He stated they would have to take the funds from somewhere else if necessary. He also explained there are several account that cover various repairs. He noted this is a capital repairs account.

Ald. Patterson commented this was on the agenda just for approval of the bid waiver.

Chief LaVecchia responded yes.

Motion carried unanimously.

8d. Ald. P. Smith and Ald. Vetro made and seconded a motion to approve the request for Allocation Transfer No. 6 (per attached memo from Milford Department of Human Services Executive Director Lisa Diamond-Graham dated December 17, 2009).

Mayor Richetelli explained the Board was being asked to vote on the revised amount, which is \$4,000 and not the \$20,000 as previously requested.

Ald. Staneski stated she works closely with the department and acknowledged how busy they are. She asked if this request would in any way hinder their coming back for additional funds if necessary.

Mayor Richetelli stated Ms. Diamond-Graham was present for any detailed questions. He stated the responsibilities in this department have increased dramatically, but that they believed the calculations arrived at should cover the rest of the year.

Motion carried unanimously.
