

**BOARD OF ALDERMEN

Chairman Parente announced the Committee would consider four ordinances as published in the New Haven Register on Thursday, November 10, 2022.

1. An Ordinance Amending an Ordinance Establishing Compensation of City Officials and Employees in the Service of the City of Milford.

Ald. Giannattasio and Ald. Vetro made and seconded a motion to waive the reading of the full ordinances. Motion carried unanimously.

Ald. Vetro and Ald. Giannattasio made and seconded a motion to forward an Ordinance Amending an Ordinance Establishing Compensation of City Officials and Employees in the Service of the City of Milford to the full board for consideration. Motion carried unanimously.

2. An Ordinance Amending an Ordinance Establishing Compensation of City Officials and Employees in the Service of the City of Milford, Article II, Public Safety Employees, Schedule K.

Ald. Giannattasio and Ald. Vetro made and seconded a motion to waive the reading of the full ordinances. Motion carried unanimously.

3. An Ordinance Amending an Ordinance Establishing Compensation of City Officials and Employees in the Service of the City of Milford (Mayor, City Clerk).

Ald. Giannattasio and Ald. Vetro made and seconded a motion to waive the reading of the full ordinances. Motion carried unanimously.

Ald. Vetro and Ald. Giannattasio made and seconded a motion to forward an Ordinance Amending an Ordinance Amending an Ordinance Establishing Compensation of City Officials and Employees in the Service of the City of Milford (Mayor, City Clerk).

Ald. Giannattasio stated the ordinances are being recommended to the full board under the executive session portion of the board meeting. He stated for informational purposes only, historically the ordinance for Mayor and City Clerk's wage increase has been presented together. He asked if they must stay together or can be separated into their own ordinance. Attorney Berchem stated elected positions cannot receive increase while in office. He stated the positions follow the supervisor's union and any increase that is approved will not go into effect until the next term following the November 2023 election. Attorney Berchem stated the question as to whether they wage increases may

be presented as separate ordinances would require further research. Ald. Giannattasio stated he felt they should be presented as two separate ordinances in the future.

Motion carried unanimously.

4. An Ordinance Amending an Ordinance Establishing Compensation of City Officials and Employees in the Service of the City of Milford (Registrars).

Ald. Vetro and Ald. Giannattasio made and seconded a motion to waive the reading of the full ordinances. Motion carried unanimously.

Chairman Parente opened the public hearing at 7:15 p.m.

Chairman Parente closed the public hearing at 7:16 p.m.

Ald. Vetro and Ald. Giannattasio made and seconded a motion forwarding an Ordinance Amending an Ordinance Establishing Compensation of City Officials and Employees in the Service of the City of Milford (Registrars). Motion carried unanimously.

There being no additional business, Ald. Vetro and Ald. Giannattasio made and seconded a motion to adjourn. Motion carried unanimously.
