V. SUPERINTENDENT'S REPORT

SEL Student Support Services

Approved

Dr. Fedigan and Mr. Brown, assisted by Dr. Golesky and Mr. Smyth, delivered a presentation on Social Emotional Learning (SEL) (on file). The presentation included a review of what was presented to the Board in December 2021. Since December, the district formed an SEL Guiding Coalition to advance work on relationships. The coalition consists of school climate specialists, mental health professionals, and teachers from all 14 schools with the purpose of advancing district work on developing knowledge of SEL and creating plans to move SEL forward in the schools, with a strong emphasis on strengthening relationships and youth development. School newsletters, SEL toolkits, schools celebrating random acts of kindness day, advisory lessons, and teachers showcasing students (just because they are special) are some examples of the work of the coalition. The district will continue its work with the guiding coalition to embed SEL throughout the schools.

Back to School Report

Dr. Cutaia was happy to share with the Board that the beginning of the school year was incredible. The staff and students were excited to get back to normalcy. Provided in the report were highlights of the work performed by the Food Services, Facilities, Maintenance, Transportation, and Human Resources departments.

Human Resources Report

Ms. Kopazna presented the Human Resources Report for August. Included in the report were the personnel changes, job postings, retirements, resignations/terminations, and stipend appointments. The district has hired 35 teachers to fill open positions. There are currently four open teaching positions.
