

- 1. Call to Order/Roll Call: Dr. Fedigan called the meeting to order at 5:32. Attendance was recorded. Lesley Darling resigned from her Council position upon her retirement.
- **2. Consideration of Minutes**: Amy Donegan made a motion to accept the June 15, 2022 Meeting Minutes. Suzanne Thomas seconded the motion. Motion passed unanimously.
- 3. By-Laws update: City Attorney Beechem reviewed and revised Council by-laws. Council had an opportunity to review By-Laws before the meeting. There were no questions or comments. Updated by-laws were adopted by Council. Chair Dr. Fedigan noted the new by-laws outline the Co-chair appointment can be filled just until the next election in January and asked if anyone was interested. The review will include Council and Program efforts to ensure the focus quality component is part of Milford Community School Readiness and determine ways to strengthen or improve the component.)

Carole Swift reported on the OEC's updating of the Sliding Scale Fee Schedule in September. The OEC expectation is that moving forward, any new enrollment will use the new Fee Schedule for fee setting.
