The October meeting was designated to planning goals for the upcoming year and to create a mission statement for The Milford Conservation Commission.

Bill emphasized the importance of reading the current Plan of Conservation and Development which is reviewed every ten years and will be reviewed for next year. There are current zoning regulations in place in this plan, but questions were raised about the implementation of these regulations in the current plan, i.e., question on impervious surfaces in a large parking area. Maureen, Carol, Danielle, Bill and Keith all attended the Plan of Conservation and Development meeting last week.

A suggestion was made that a sub-committee of members of The Conservation Commission and other groups within Milford interested in land use issues meet to discuss the use of The Plan of Conservation and Development. It was agreed that a cohesive environmental group needs to put together a sub-committee to have an opportunity to have an effect on the legislative/regulation area of The Plan of Conservation and Development. It would be important for this group to advocate for taking care of the land we have in Milford.

Keith explained the state program of farm selling development rights.

Maureen developed a presentation to coincide with goal planning titled "Recommending a Strategy" which she handed out in binder form to the commission members. She also handed out the State of Connecticut general statutes for a conservation commission.

It was agreed that the chair of each sub-committee will give a brief summary at the November meeting. They will also email the summary to Bill prior to the next meeting so he can include this on the agenda.

- 2. Speaker Maureen spoke to the land trust speaker from last year's CACIWC meeting. He said he would be willing to speak to the commission members at an upcoming meeting.
