BOARD OF FIRE COMMISSIONERS REGULAR MEETING September 15, 2009

The Board of Fire Commissioners held their Regular Meeting on Tuesday, September 15, 2009 at Fire Headquarters, 72 New Haven Avenue. Chairman Riso called the meeting to order at 7:05pm.

1. Roll Call

Commissioners' Thomas Riso, John Healy, Carmen Corvino, Richard Smith, William Brennan, Howard Stein and Jonathan Berchem. Also present were Chief Louis A. LaVecchia, Assistant Chief Daniel L. Johnson and Assistant Chief Robert J. Healey

2. <u>Public Statements limited to the function of the Board of Fire Commissioners</u> None.

3. Consideration of Minutes of June 16, 2009

Commissioners' Corvino and Smith made and seconded a motion to approve the minutes of the June 16, 2009 meeting as presented. Motion carried 6 yes (Commissioners' Riso, Healy, Corvino, Smith Brennan, Berchem) and 1 abstain (Commissioner Stein, not present at June 16, 2009 meeting).

Consideration of Minutes of Special Meeting July 21, 2009

Commissioners' Healy and Smith made and seconded a motion to approve the minutes of the Special Meeting July 21, 2009 as presented. Motion carried 6 yes (Commissioners' Riso, Healy, Corvino, Smith, Brennan, Berchem) and 1 abstain (Commissioner Stein, not present at July 21, 2009 special meeting).

5. Committee Reports

- Commissioner Brennan reported the Sub-Committee formed to review fire stations and capitol improvements met in early July to assess the need for a new fire station.
- AC Johnson reported on Apparatus stating all trucks are in service at this time with the exception of Engine 8 and Engine 9, which are in for routine maintenance.

6. Chief's Report

- Jim Amann called and asked me to support him in his run for Governor. Jim supports the fire service in many ways and supported Milford Firefighters assisting with a tuition reduction program. Jim is a local 'Son of Milford' making this a special case for me and so I am asking permission from the Board of Fire Commissioners for myself and the Union to assist Jim Amann in his run for Governor, while in uniform, further asking for an exception to General Rule 23. Commissioner Stein said it could be a problem when you get into partisan politics. Chief LaVecchia stated I think this is a unique situation. Commissioner Corvino agreed. Discussion ensued. Commissioners' Corvino and Healy made and seconded a motion: The Board of Fire Commissioners suspends General Rule 23 to enable the Department to support Jim Amann's candidacy for Governor. Motion carried 6 yes (Commissioners' Riso, Healy, Corvino, Smith, Brennan, Berchem) and 1 no (Commissioner Stein). Assistant Chief R.J. Healey stated according to the rules, this needs to be posted.
- On the recommendation of Commissioner Brennan, while attending Fire Chief's Conference, Chief LaVecchia stopped by the Supthen display and mentioned our problems with our Quint. They were surprised they hadn't been notified and promised results.
- AC Johnson reported that he along with EOC Coordinator Dan Worroll, and Senior Fire Inspector Andy Vargo met with Ruth Parkins, Manager of Public Affairs for Iroquois Pipeline Operating Company to discuss some of the Departments needs and read the following from an e-mail he received dated 9/16/09 from Ruth Parkins: I have spoken to Mayor Richetelli and he is fully supportive of the Fire Department receiving a project-related community grant from Iroquois as follows: \$9,000 to cover the cost of unlimited minutes for the Code Red system for one year (June 2009-May 2010) and \$10,187.59 for the purchase of

a Live Fire Extinguisher Simulator Training System. However, the Mayor indicated that prior to accepting the funding, the Board of Alderman must approve it; therefore it will be on the agenda for consideration at their October 5th meeting. Discussion ensued regarding Code Red unlimited minutes cut from the budget and details on the Simulator Training System. Assistant Chief R.J. Healey said the grant would be beneficial to our citizens and would enable MFD to provide Industry requested training at places like the Hospital and Nursing Homes.

9. Comments/Concerns of the Commissioners:

- In follow-up from Chairman Riso to AC Healey In your July report you noted an incident involving a resident's repeated visits to Station 8. AC Healey said it has resolved itself.

 Executive Session to discuss two personnel matters and ISO. Motion carried unanimously.
 Chief LaVecchia, Assistant Chief Johnson and Assistant Chief Healey remained at the request of
 the Commission. At 9:00pm Commissioner Berchem left Executive Session. At 9:13pm
 Commissioners' Healy and Smith made and seconded a motion to come out of Executive
 Session. Motion carried unanimously.
- Per ISO recommendation, the Board of Fire Commissioners formally requests that Mayor Richetelli form a citywide fire station needs committee with the scope and charge to:
 - 1. Evaluate the current locations of the city's fire stations and make recommendations to add, combine or eliminate any of the current fire stations.
 - 2. Determine the best location for any needed fire stations.

Commissioners' Smith and Stein made and seconded a motion to adjourn at 9:17p.m. Motion carried unanimously.
