### V. Committee Reports

a) <u>Planning Committee</u> – Commissioner Healey stated the course will open Monday. The clubhouse lobby area will be cleaned and ready for Monday's opening.

Chairman Austin asked if the Commission wanted to consider purchasing 2 new golf carts.

Chairman Austin asked if there was any discussion. Commissioner Healey commented it would take approximately 6 weeks to receive the new golf carts and the electrical work would be done by that time. Commissioner Austin commented only 2 more could be purchased. Commissioner O'Connell asked management if they could accommodate 2 new golf carts. J. Fabrizio responded there was room for 2 new golf carts.

# VII. Management's Report (Tournament Turf Care, LLC)

J. Fabrizio commented that Don's Tree Service had caused some tire rut damage to the course while doing some tree work. Mr. Fabrizio will research the damage and necessary repairs before paying Don's Tree Service. Commissioner O'Connell stated he will contact Don's Tree Service, walk the course with him and discuss remediation.
