- R. Swift reported the permits from the DEP and the material from the Army Corps of Engineers was received and that the contract with the dredging company was signed today.

- R. Swift noted that he felt that the Alderman were not as well informed as they could have been about the project at the meeting.
- R. Swift noted that knowing the hard work it took to get the permits and the project off the ground, that it was difficult to listen to the members of the Board of Alderman; and that if the Democratic Liaison was present at the monthly meetings then the BOA would have been better informed.
- The Chairman noted that with R. Swift's conservative budget and the funds in the account, the commission will be able to do more for the Harbor.
- R. Brennan inquired as to the concession stand status.
- R. Swift reported that Wayne isn't coming back and that he hasn't solicited anyone else, because of losing 2 spaces and the bridge being closed, it might not be a good idea.
- R. Swift noted that the City Attorney informed him that the concession stand is not an expense and thus does not have to be put out to bid.
