Chairman Post handed out the schedule for our 2013 meetings.

Director's report

Columbus Day weekend was sold out (at a reduced rate but full) There were two clubs in attendance.

Ray has rented dock space to two clam boats from the day after Columbus Day to May 15 – both from Bloom Brothers and they are good tenants. This is the second year Ray has done this – income is about \$4,500. Extra. If we have a harsh winter, it helps keeping the channel clear.

Work has started on the docks, two of the crew Don and Kyle have been working part time helping with the construction. 5 are done, total of 8 to be built. There is an account with money in it and we will probably get the decking done this fall rather than wait until the spring. The mooring floats will be brought in after Nov 1st.

Harbormaster:

Bruce reported that he is working on consolidating all the different forms we have and that after that job is completed he will get together with Ray to go over the renewals for next

year. Renewal date will remain at October 31. Applications will still have the same date. He is hopeful this work will help in streamlining the renewal process.

Milford Landing:

Another suit has been filed for a slip and fall on the premises. The one last month occurred August 4 and this one was August 5^{th} . Kim Kell, city risk manager, said it may be time to meet about the patio and the public access to it.

Purchasing agent and Roberge have been going back and forth deciding when to put the dredging process out for bid, due to the expense of advertising each time a bid goes out.
