D. New Business

MILFORD INLAND WETLANDS

D.1. <u>IW-PA-19-025: 750 Bridgeport Ave, Map 33, Block 386A Parcel 3</u> Country Motors II. Soil excavation and stabilization with work within 100' of a wetland in the Housatonic River Watershed. [4/17/19||5/3119||6/1/19]

Compliance Officer Palumbo stated that the proposal is by GEI on behalf of County Motors II for the removal of impacted soils. They propose to remove about 600 cubic yards of soil with an excavator to be parked on the adjacent asphalt lot. Once sufficient soil is removed, the area will be backfilled with new material and loam and seed for stabilization. Silt fencing is proposed around the work area. She passed around a sheet with 3 photos of the site for the Commissioners to view.

Kelsey Shields, GEI Consultants, Glastonbury, CT, appeared on behalf of Country Motors II. She said the site was formerly known as Bobs Motors and that two dumpsters were positioned on concrete to the rear of the property. She said that due to poor management practices over the last few years, there had been petroleum product dumped and/or spilled in this area. The plan is to excavate approximately 600 square feet of soil to a depth of one foot and dispose of it off site. Once confirmation samples indicate that the area is clean, they will install geotextile fabric, backfill with clean material, and stabilize the area. She said that Photo #2 on the photo sheet shows the area to be remediated. She also referenced the map submitted with the application entitled Erosion Control Plan.

Compliance Officer Palumbo asked if remediation was limited to petroleum spillage or if windblown debris in the wetland areas would be removed during this clean up phase. She also asked if the detention pond area had been tested and whether the test revealed any work being necessary. Ms. Shields said they can clean the area that they are working in. She said surface water sampling of the pond revealed nothing above state action levels.

Compliance Officer Palumbo noted that knotweed is visible on the site and asked if there will be invasive species monitoring while the site is revegetating. Ms. Shields said there is no plan in place to prevent invasive spread because the area they are working in is small compared to the amount of invasives on the site. She said they are proposing to loam and seed the area, with no plan to hydroseed.

Commissioner Munson questioned if wells will be monitored. Ms. Shields said that the wells are from previous company's reviews of the site and that no contaminants were found in the ground water monitoring. She stated that the only remediation required is with the soil in the proposed area.

Commissioner Cowden said that he expected trash to be removed from the yard area when the work is done. Ms. Shields said clean up would extend to the debris around the dumpster where they are working.

Compliance Officer Palumbo reviewed options for the commission, noting that this is a preapplication received at this meeting. She said that at this meeting the Agency can:

- Ask guestions
- · Ask for further information
- Issue a Jurisdictional Ruling
- Require a Full Application
