Discussion ensued among the Commissioners regarding an appropriate amount of increase for the parking fee, enforcement, parking locations, parking meters/kiosks, hiring of an individual; fee comparison with local towns and communities and the State's potential charge for Silver Sands Beach; and, the proposed changes to the appropriate Ordinances to be presented to the Ordinance Committee in order for this to take effect.

Vice Chairman Fabian makes a **Motion** as follows: That the Park, Beach and Recreation Commission make a recommendation to the Ordinance Committee that the daily Non-Resident parking fee be raised to \$15.00 per day, or, any portion thereof, as outlined in **Sec. 14-13**;

And, that the Park, Beach and Recreation Commission also recommend to the Ordinance Committee that the fee be applicable from the Saturday prior to Memorial Day to, and including Labor Day, during beach hours;

And, that the appropriate changes are made in any other Section(s) of the Ordinances to reflect the new fee, dates and other necessary language.
