1. Golf Course Committee – Chairman Worroll – The Board of Alderman approved funding for the construction of a new building to house maintenance equipment with repairs being made to the existing building. The golf course is opened and doing well.

- 2. Walnut Beach Enhancement Committee Chairman Worroll The Grant extension was approved to extend to the end of December 2014. New garbage cans have been installed and the snow fence will be installed in the near future.
- **3. Bench Dedication Program** Chairman Fabian Fabian advised that three new benches for Richard Platt, Historian, Dr. Rauch, and Ruskowski have been installed. The Richard Platt bench is tentatively scheduled to be dedicated on June 12. There has been additional interest from individuals to installed more benches as well as possibly doing a bench slat replacement at Parson's Complex and a new bench to be located at Myrtle Beach in memory of City Clerk, Linda Stock, who recently passed away.
