a) <u>Update: Turf Fields Project</u> - Director Piscitelli reported the turf fields are in use and in great demand. He stated that the department has received many compliments on the facility. He stated there are still some outstanding punch list items to complete. In addition, the department is working on outfitting the concession stand.

Mr. Piscitelli stated once the concession stand is operational, there will be an opening ceremony.

Mr. Pisctirell also updated the Commission on the tennis courts. He stated they are open for play after being completely renovated. He added there are some final touches, such as benches, trash receptacles, etc.

Vice Chairwoman Fabian asked who would reap profits from the concession stand.

Director Piscitelli stated any revenue generated from the concession stand would go back into the fields for maintenance, upkeep and improvements. He stated a date for the grand opening would be determined.

He also reported the tennis courts at Eisenhower Park and stated they would be ready for opening in two weeks.
