Mr. Cody asked about the fees that he charges and Mr. Paolini stated that the quarterly reports are approximately \$4,000.00 for the year and the year end report is \$6,500.00.

Mr. Cody stated that Hooker & Holcombe will be at the September meeting to discuss the pension adjustment study with the Board. The Board will be making a recommendation to the Board of Aldermen regarding possible increases to the retirees. Mr. Cody stated that he had appeared before a Board of Aldermen meeting to address the last time that increases were recommended to them. He stated that they do not receive all the information that this Board does and they need to be made aware of the fact that if increases are recommended this may result in an increase in what the City has to contribute to the pension fund. He noted that the police and fire retirees get increases based on their contract. He asked the members to review the study and prepare any
