Chairman Sartor called the meeting to order at 8:10 p.m.

Disposition of Minutes:

Mr. Whitaker moved to accept the minutes of the September 18, 2008 meeting. The motion was seconded by Mr. Eisenhandler and carried unanimously.

Report of the Chairman

Mr. Sartor stated that Mr. Cody will give a report of the managers' meetings. Mr. Cody stated that the Board has been invested in the Bespoke Program with Merrill Lynch for two years and we are only one of four groups still in the Program. Merrill Lynch is not really supporting the Program any more; they are not investing any more time or resources to it. It would be the recommendation to move the funds to the Stamos Group. Mr. Sartor stated that in order to move the funds 60 days advance notice for redemption is required. Mr. Cody further explained that 5% is withheld until the year end audit and then it is returned to the client. This was also the recommendation of Mr. Beirne and would be a lateral move of funds. Mr. Sartor pointed out that the portfolios will not be rebalanced at this time. Mr. Mahoney stated that he felt that the redemption should be done at this time but no decision should be made as to where the funds will be going. The Board could decide at a later date whether to invest in the Stamos Group or do something else with the funds.

Mr. Cody moved to make preparation to do the redemption of the funds in the Bespoke Program at this time. The motion was seconded by Mr. Elwell and carried unanimously.
