Report of the Investment Advisor

Mr. Beirne presented the reports for the quarter ending November 30, 2012 and reviewed them with the Board.

Mr. Beirne stated that Omega Advisors, Inc. recommended placing 5% of the portfolio with them. He recommended that some of this come out of cash and the Neuberger Berman Large Cap portfolio. The investment with Omega Advisors will give the portfolio a more diversified portfolio as well as more value and more growth. He stated that they are more of an equity manager than an alternative manager.

Mr. Cody moved that 5% of the portfolio be placed with Omega Advisors, Inc. The motion was seconded by Mr. Staneski and carried unanimously.

The Board discussed the Zesiger portfolio with Mr. Beirne and Mr. Beirne stated that he met with them and discussed their approach to investing. He stated that he felt a letter should be sent to them instructing them not to hold onto investments in the portfolio that have dropped significantly in value. The letter should also indicate that the Board is looking for better performance from them in the emerging markets. Mr. Beirne stated that he will prepare the letter for the Board to send.
