3. CITIZEN COMMENTS

- Ald. Vetro thanked Chief Mello and his staff for persistence in obtaining grants from the State
 of CT to assist in fighting crime in our city.
- C. Jermain 2 Little Pond Rd directed comments to statement made by Chief Mello during last month's meeting regarding what department has jurisdiction over safety and site line violations. She explained that she thought the Chief had stated the MPD had that authority.

Chief Mello interjected he had stated it was "this board of commissioners" (i.e. Milford Police Commission).

Ms. Jermain went on to share a recent conversation she had with Public Works Director; also expressed her disappointment in the fact that the minutes of the March meeting did not refer to a letter she had presented to the Chief at that meeting and a list of names of area residents in support of the request for the intersection of Morningside & Little Pond Rd.

Chief Mello explained anything presented at the meeting is included as part of the official record.

Comm. Jagoe explained this commission's rules indicate that we give members of the public the same courtesy and time limits as given by the Board of Aldermen which is three minutes.

Chrmn. Smith also explained that the Citizen Comment portion of the meeting should not be a forum for public debate.

K. McGuire – 29 Hilldale Court - corrected her address as noted in the March Police Comm.
 Minutes. She explained the cul-de-sac where she resides is the only exit from the
 neighborhood onto Morningside Dr. and added that although she does not reside on Little
 Pond, she is concerned about this request. Further she made reference to the March minutes
 of the Police Commission and the statement made by Chief Mello that he felt there was no
 reason to revisit the request again.

b. Request for Westbound left turn lane extension – Bridgeport Ave/Naugatuck Ave – Chief Mello explained this request was called into the Mayor's office from a citizen regarding the turn lane. He stated there is currently a flare in the road to allow cars to queue out in the left turn lane and this request is to have the 2nd lane extended resulting in the loss of three parking spaces on the south side of Bridgeport Ave. He noted this will be a request to DOT as well since this is a state road.

Comm. Faruolo asked if the loss of the parking spaces will impact the parking for local businesses and she expressed her concern regarding the loss of those spaces.

Chief Mello explained with the exception of the bar on the corner, most customers park in the rear parking lot.

It was moved by Vice Chrmn. Bergami and seconded by Comm. Wanosky to approve the request for Westbound left turn lane extension as explained by Chief Mello.
