# 3. CITIZEN COMMENTS

J. Carissimi – 64 Kirkside Ave. - addressed the board on three matters. He acknowledged the work and dedication of the Citizens Police Academy Volunteer Program noting the number of volunteers who served at various events in the city. He also took the opportunity to thank and recognize Chief Mello and the Department for the very good relationship the public has with the Department. He stated that relationship comes about through Chief Mello. On behalf of the Wildemere Beach Association, Mr. Carissimi thanked the Chief for the police presence in the neighborhoods over the past few weekends. He noted that recently the Association had their annual picnic and extended an invite to officers and some of them actually attended the picnic. Mr. Carissimi also extended thanks for the opportunity for the volunteers to provide coverage at the Pumpkins on the Pier event and also the upcoming Drug Take Back Day.

Chief Mello commented on these volunteers making special note of the assistance they provided to the Department during the difficult days following the passing of Michael Compare. He stated their commitment is very much appreciated.

Ald. Vetro stated he has received comments from residents in the Viscount Drive/E. Broadway
area regarding the "Yield" sign at the intersection of Viscount Drive and East Broadway. He
stated residents are asking if the Department could revisit that signage and consider changing
the "Yield" to "Stop".

It was moved by Comm. Wanosky and seconded by Comm. Jagoe to add to the agenda item 6 h. Safe Driving Awards for the following Officers: A. Aquino, D. Bedecker, C Bothwell, DeVito, Hoff, Mauro, Det. Haas, Det. Moreno, Det. Noss, Sgt. McNemar. Motion carried unanimously.

# 5. READING OF CORRESPONDENCE

Chief Mello shared the following correspondence:

He explained the Maryland Dept. initiated a response to threats against students in Milford from an individual in Charles County.
- Dee McLenihan, Wepawaug Valley Scouts Coordinator acknowledged and thanked Officer Dempsey for providing safety talk at camp; Officer Covelli & Zeus for the K-9 visit to the camp which the campers enjoyed very much.
- Alexandra Winkelmer expressed thanks and appreciation for police mobile unite at Walnut Beach.
- Numerous cards from campers at Woodruff Family YMCA.
- State Police, Narcotic Task Force acknowledged and thanked Sgt. Cruz for his efforts in the Northwest Office of the State Narcotic Task Force
- Stefani Corsi Trovali praised and thanked Officer Bova for his investigation and locating loss of valuable personal item.
- Michael DeGrego resident thanked Sgt. Simpson and Officer Bodnar who responded to an accident at his home; acknowledging their professional and courteous action.

Chief Mello noted since the Department has gone to the combined dispatchers, the Department is no longer delayed in getting a call such as this. He stated this is another example of how the city has benefitted from combined dispatch.

- Rep. Pam Staneski, 119 District thanked Chief Mello for department's attendance at the forum on identity theft recently held in Milford.
- Jacqueline Rizzardi acknowledged Officer Moreno who assisted in finding homeless person in our area noting he clearly shoed empathy for homeless individuals. He was genuine, polite and respectful and he explained areas where this individual may be found.
- Ray Vitali, on behalf of the United Way of Milford thanked the Department for their support at the 5<sup>th</sup> Annual Ride for Hope and providing escort services ensuring a safe ride for all.
- Packet of letters from Harborside Middle School students project they participated in with a theme of kindness and how it related to our city and the Police Department.

# 6. CONSIDERATION OF REPORT OF CHIEF ON MATTERS OF ADMINISTRATION

a. Donation from car seat inspection – Chief Mello recommended the \$10 donation from Lucille Ferrar for car seat inspection be placed in the DARE Donation Account.

It was moved by Comm. Wanosky and seconded by Comm. Rubinstein to accept the \$10 donation from Lucille Ferrar and place this donation in the DARE Donation Account as recommended by Chief Mello. Motion carried unanimously.

b. Car seat donations and other items from Yale Children's Hospital – It was moved by Comm. Wanosky and seconded by Comm. Marrone to table this matter as recommended by Chief Mello. Motion carried unanimously.

c. Donation from Rotary Club of Milford for body cameras – Chief Mello stated the Rotary Club of Milford has donated \$1,500 for the purchase of two body cameras but since their initial interest, the state now will reimburse departments for this equipment. Chief Mello stated he will contact Rotary leadership to see if they would like this donation to be applied elsewhere in the Department.

It was moved by Comm. Wanosky and seconded by Comm. Rubinstein to table action on the donation from the Rotary Club of Milford for body cameras as recommended by Chief Mello. Motion carried unanimously.

Discussion ensued regarding body cameras and the money reimbursed by the state to purchase the cameras. Chief Mello explained because this is grant funding, the city must adhere to policy guidelines. He stated departments will be obligated to maintain program and the video storage. He noted that unless the state continues to provide funds, the municipalities will have to fund the storage and replacement cycle of this equipment. As well, based on an FOI request, the time involved by department staff to comply with the request is also costly as it must be a sworn officer who reviews/redacts the tapes before releasing them.

Comm. Jagoe asked if it is a law that each department has body cameras and Chief Mello explained the statute requires if the departments have the cameras they must adhere to the governing policies. He went on to explain that next year our Department will have another \$100,000 entering the budget for the combined dispatch system and that added to the cost of the cameras will be a concern to him.

d. Donation from Carubba for Awards ceremony – Chief Mello recommended the \$500 donation from Carubba be applied to the recognition ceremony to be held in the future.

It was moved by Comm. Wanosky and seconded by Vice Chrmn. Bergami to approve the \$500 donation from Carubba and apply those funds to the recognition ceremony. Motion carried unanimously.

e. Donation of toys for Patrol vehicles from Lauralton Hall – Chief Mello explained Lauralton Hall donated a number of toys to be placed in patrol cars to be given to children, perhaps a child in crisis.

It was moved by Vice Chrmn. Bergami and seconded by Comm. Rubinstein to accept the donation of toys for patrol vehicles from Lauralton Hall. Motion carried unanimously.

f. Informational: Officer Gary McDonnell has resigned effective 9/17/15.

g. Chief's General comments – Chief Mello stated the next Police Academy will be starting 10/26/15 and he anticipates 8-10 of our own officers in that academy.

Further, he noted David Sulkis, City Planner, has requested a meeting with the Chief to discuss this commission's role in reviewing P & Z requests.

Comm. Jagoe felt an opinion from the City Attorney on this matter would be advisable.

Chrmn. Smith felt having clarity regarding this commission's role is important.

Chief Mello explained matters regarding public safety and site lines are the role of this commission on the review of P & Z requests.

Chief Mello stated he will coordinate a meeting time with Mr. Sulkis and Chrmn. Smith will also attend.

Noss, Sgt. McNemar and award eight hours of comp time for an accumulation of 12,000 safe driving miles with no safety violations to the officers noted. Motion carried unanimously.
