- a. Consideration of the 2015/2016 Police Department budget request. Chief Mello reported the 2015 budget was completed and delivered to Mayor Blake last week. He added if any of the commissioners had any specific questions regarding the budget document, he would be happy to go over such matters with them
- b. Deputy Chief Tracy Mooney will retire on or about 12/4/14 Chief Mello stated it was with great sadness and congratulations to our Deputy Chief Tracy Mooney who will be retiring on 12/4/14.

He added it is a good way to maintain a healthy environment and good for the entire force.
