The Board of Aldermen of the City of Milford held their Regular Meeting on Monday, January 6, 2014 in the aldermanic chambers of City Hall. Chairman P. Ald. Vitali commented he understood the Capital Improvement Plan (CIP) is a plan with changes to be made. He stated he was disappointed with the Board of Education that a 5-year plan still is not in place and that budgets should be based on assumptions. He stated this Board asked the Board of Education for a plan two budgets ago and still have not received anything. He stated included in the CIP are roof replacement on schools that could possibly not be in place. He stated he just could not support the plan with so much unknown information.

Mayor Blake stated the CIP is indeed a blue-print, a planning tool with a rough financial outline over the years. He stated it also qualified the City for State and Federal grants. He also stated none of the items obligates the Board to funding, which comes later. Mayor Blake stated Ald. Vitali's point is a good one, agreeing that the Board of Education needs to come out with a comprehensive outline before the Board can make any recommendations to the Board.

Ald. Vitali stated he did not feel the Board of Education was moving in a timely fashion and that in some respect they were putting the "cart before the horse."

By roll call vote, the motion carried 11 yes (Bier, Asey, German, Giannattasio, Hardiman, Kubek, Shaw, Smith, Stanford, Veccharelli, Vetro) and 2 no (Fontana, Vitali).
