BOARD OF FINANCE PROPOSED BUDGET 2011-20112 – FINAL VOTING SESSION MARCH 9, 2011

The Milford Board of Finance held a budget deliberations session on Wednesday, March 9, 2011 in Conference Room B of the Parsons Complex. Chairman Lema reconvened the budget session at 6:35 p.m.

Chairman Lema stated tonight was the final vote to adopt the budget for 2011-2012. He noted he received three pieces of correspondence since the last meeting. A letter from the Department of Permitting and Land Use dated March 7, 2011; a letter from the City Clerk dated March 3, 2011; and a letter from the Public Health School Nurses dated March 7, 2011. Chairman Lema explained the process tonight is tedious, but they do proceed page by page, department by department, line item by line item.

Vice Chairman Beckwith and Mr. Marlow made and seconded a motion to approve the following Mayor's recommended budget as presented: 4111 Board of Aldermen. Motion carried unanimously.

Vice Chairman Beckwith and Mr. Marlow made and seconded a motion to approve the following Mayor's recommended budget as presented: 4112 Elections. Motion carried unanimously.

Ms. Doneiko explained it is through the debt service reserve fund, which is also used to pay don on the sewer use portion.

Mr. Agro commented they have received a great deal of contact from the school nurses. He stated it shows the gravity of the circumstances they are faced with. He went on to speak of the budget, explaining tonight was just the third of four steps in adopting the budget. He told those present there would be an opportunity to discuss this issue with the Board of Aldermen.

Mr. Beckwith commented he takes his vote tonight very seriously, but reiterated this is still the early part of the process. He stated at this time this is the Board's best estimate of where they are with revenues. He stated these are just more than numbers, there are faces. He also stated the economy is still tough and that the city is at a crossroads and this board has to make some decisions and it has been very tough. He reiterated this is about people, their lives and how this budget will impact them.

Chairman Lema spoke regarding the anticipated revenue the city expects to receive from the state, which he stated is significantly less than expected. He stated given the uncertainty in Hartford it would not be responsible for this Board to rely on numbers that may not end up coming to this town.

Mr. Fitzpatrick asked for clarification regarding line item 3655 0000 State PILOT: Boats.

Mayor Richetelli explained it was because the City received less from the State.

Motion carried unanimously.

Vice Chairman Beckwith and Mr. Marlow made and seconded a motion to approve the Mayor's recommended budget as presented: 4121 Golf Course (Revenues). Motion carried unanimously.

Vice Chairman Beckiwth and Mr. Fitzpatrick made and seconded a motion to approve the Mayor's recommended budget as presented: 4121 Golf Course (Expenditures). Motion carried unanimously.

Vice Chairman Beckwith and Mr. Marlow made and seconded a motion to approve the Mayor's recommended budget with the following changes: 0010 0000 General Fund Revenue, line item 3670 0000 Manufact. Machines/Equip. to read \$0 from \$1,088,621 for a new sub-total in State PILOT Grants of \$1,855,118 and a new department total of \$29,126,103.

Mr. Agro asked about line item 3831 0004 and asked the length of the agreement.

Mayor Richetelli stated the Milford Power agreement is a 10 year agreement. He stated the GenConn agreement is a 30 year agreement.

Mr. Agro asked about discharges if they were to file bankruptcy.

Mayor Richetelli explained there are many safe guards in place in the agreement.

Mr. Fitzpatrick asked about line item 3765 0000 Sales Tax.

Ms. Doneiko explained it is a placeholder if the Board of Alderman decides to consider it.

Chairman Lema commented he had concerns about other items, in particular the conveyance tax. He stated they are budgeting slightly less than last year, but given the poor real estate market and the low number of transactions, he stated he was concerned they might not meet the number.

Mayor Richetelli stated there are many questions they are still awaiting from Hartford. He stated the Board of Aldermen would likely have more information when they get the Board of Finance budget.

Chairman Lema asked about line item 3643 0001 State Realty - Pequot.

Mayor Richetelli responded that was the number the governor recommended.

Chairman Lema asked about the ECS portion of the grant and if it was the same as last year.

Mayor Richetelli stated the federal stimulus money is gone. He stated the governor has proposed an increase, but without solid information that it will in fact happen, the Board of Finance could at this time elect not to add the money until confirmation has been received about those funds.

Mr. Fitzpatrick asked about the school debt and if it included interest and principal.

Ms. Doneiko stated it is old debts issued before 1996. She went on to explain the process and the bonding for a project. She stated over the next 8 years it should disappear.

Motion carried unanimously.

Vice Chairman Beckwith and Mr. Fitzpatrick made and seconded a motion to approve account 4996 Education Operations as follows: line item 4001 0000 Lump Sum Appropriation to read \$84,477,440, which represents a 1.5% increase or a \$1,248,435 increase over last year's budget.

Chairman Lema stated this Board has discussed this number at length. He explained they were not budgeting an increase in ECA monies at this point, however they were fairly optimistic there would be an increase. He stated he would support an increase of the education budget by 1.5%, which would represent a budget of \$84,759,589.

Mr. Agro stated with the difficult economic times and the decreases this Board has made tonight he would be comfortable with the number recommended by Mr. Beckwith.

Chairman Lema stated his message to the Board of Aldermen would be if the ECS monies due come into the City that the Board of Aldermen consider funding the Board of Education at a higher level. He stated hopefully more revenue would come, but that he would be comfortable passing this budget as it is and have the Board of Aldermen prioritize individually. He expressed his hope it would be conveyed to the Board of Aldermen that this Board is very hopefully more revenue is coming.

Mr. Fitzpatrick pointed out it is still an increase and also noted this Board just cut \$1,000,000 from the city side. He stated the amount recommended by Mr. Beckwith is justified and reminded the members of the Board they were talking about taxpayer dollars and that they taxpayers needed to be considered. He stated it was important to keep the budget as close to a \$0 increase as possible. Mr. Fitzpatrick stated these are still tough time and that the Board needed to be prudent and work within the means of the City.

Mr. Beckwith commented he along with Mr. Marlow have served on the Board of Education. He stated he would like to commend Mr. Cummings and the Board of Education for their work. He noted they have been transparent in their needs and also that they do receive many unfunded mandates, i.e. VoAgo Program. He stated because of that mandate the city pays \$250,000 yearly for the program. Mr. Beckwith stated he agreed with Mr. Fitzpatrick that this Board needed to do its small part so that people can afford to live in Milford. He stated as much as he would like to support the education side, this Board needed to be practical. He stated if additional funds do become available; it would be up to the Board of Aldermen to restore the funds.

Mr. Marlow added he agreed with most of what was being said tonight, adding it is a very tough budget year. He stated they are talking about people and not just numbers. He continued they were here to live within their means and as a Board of Finance they have to balance revenues and expenses. He stated the Board of Aldermen would have the ultimate say. Mr. Marlow thanked the department that came before the Board. He reiterated as a city we have to live within our means, just like we would at home.

Mr. Agro stated he was grateful for the steady hands of both Mr. Cummings and Mr. Russell with the difficulties the school was facing. He also recalled what the economy was like two years ago and that there was a sense of terror. Mr. Agro also recognized all of those municipal unions who came forward and worked with the mayor and negotiated there would be no increase with no layoffs. Mr. Agro stated at that time the Board was looking at the possibility of lays. He stated he was hopeful they had weathered the worst, but he was not sure the economy has fully recovered at this point. He stated the numbers are difficult, but extrapolations. He thanked everyone for all of the solutions during the last few years. Mr. Agro also stated he hoped the economy would soon turn the corner, but acknowledged there is difficulty with the costs of healthcare. He spoke regarding the city's debt which he stated is up from last year, but noted they spent the most, but a lot of those monies were for sewer plans and that there should be a long life expectancy. Mr. Agro apologized to anyone tonight's decisions may leave in personal difficult, but renewed his hope the economy would finally turn the corner. He expressed his appreciation to the department heads, Boards and Mayor during this time.

Motion carried unanimously.

Chairman Lema stated the Board would take a 5-minute recess. The Board recessed at 8:33 p.m.

Chairman Lema reconvened the meeting in public session at 8:42 p.m.

Vice Chairman Beckwith and Mr. Fitzpatrick made and seconded a motion to approve the General Fund Summary of Expenditures in the amount of \$182,770,067; and line item 3111 0000 Current Taxes to read \$153,643,964 as recommended by the Board of Finance; with a mill rate calculated at 29.35 mills as recommended by the Board of Finance.

Mr. Agro acknowledged the Finance Director and her staff and thanked Ms. Doneiko for her help and guidance through the budget process.

Chairman Lema thanked Mr. Beckwith as well and expressed his appreciation of everyone during the entire budget process.

Being no further business to discuss, Mr. Fitzpatrick and Mr. Agro made and seconded a motion to adjourn at 8:50 p.m.
