4. Review of Minutes

a) Meeting 2/16/2016 – Dan Drago motioned to approve the minutes as submitted. Keith Dunn seconded the motion. It was voted 8 in favor to approve.

5. New Business

- a) Conservation Commission 101 Steve Johnson reviewed roles of the conservation commission for Open Space monitoring. Commissioners can get copies of any baseline parcel data that includes maps that Johnson has compiled on an estimated 642 parcels totaling 3,187 acres.
 - 1. Become familiar with the parcels. What are the natural resources, such as wetlands, streams, vernal pools, vegetation, wildlife, etc? What are the seasonal changes? What are the points of interest that help tell the story why this place is important? What are the threats such as possible encroachment by tree cutting, yards, sheds, dumping, invasive plants, wildlife, ATVs, Dirt bikes, trucks, graffiti, etc.
 - 2. Commissioners can share points of interest and concerns with the Johnson for follow-up. They should be observers and be helpful.

 - 1. Promoting Open Space walks, natural resource inventory & monitoring to "tell the story" led the list with seven votes.

 McAllister suggested creating an Open Space "tool" sheet that can help identify and share what are the important points of interest in our conservation areas. This tool could be adapted and refined over time.
 - 2. Native Landscaping McAllister offered to develop a reference list of various resources including books, websites, experts at UConn, etc. Alling suggested that the very broad lists of native alternatives can be selected for Milford and our typical planting conditions. This list can be share with various departments and volunteer groups. McAllister has a several options of CT nurseries that have natives. Mauro DeSantie also suggested Ganim's Garden Center's Conservation Plantings selection of natives. Johnson will share his resources with McAllister who will coordinate.
 - 3. Earth Day Johnson updated a number of related Earth Day projects that are being developed. He encourages Commissioners to help with one or several events.
 - 1. Traditional Earth Day, April 22nd celebrate with family and friends promoting conservation.
 - 2. Possible Pumpkin Elementary School memorial garden project, date TBD.
 - 3. MacKenzie's May 7th Walnut Beach cleanup
 - 4. Academy High School, Shipyard Lane to finish plantings from 2015 and adding native understory trees and shrubs at the invasive restoration site along the path leading to the observation deck.
 - 5. Milford National Lou Gehrig Little League is interested in providing an electronics recycling and litter clean-up down at Fowler Field.
 - 6. Water Quality Dan Drago is interested in exploring water quality projects.
 - 7. Project Green Space & Purple Coneflower projects. Both of these have been postponed for this year.
