- **4. Minutes** May 16, 2017. Dan Drago motioned to revise the May 16th 2017 minutes to reflect the May 16th date, not the 17th as included on the original version. Discussion on the minutes took place. The motion to accept the minutes of May 16, 2017 as corrected was seconded by Howard Haberman was passed 5:0.

5. New Business

Dassault Systems and the Girl Scout Daisy Troop 30347 contributed a total of \$900 toward these projects. Milford Earth Day contributed an additional \$900 towards these community projects. Additional weeding, watering, and mulching will be needed to help these projects be a success.
- b. CIRCA Dune Grant & UI Donation Johnson briefly discussed the generous \$10,000 contribution that UI made to continue expanding the dune restoration at Walnut Beach. Janet McAllister and Carolyn Alling offered to assist with developing a future project action plan.
- c. Bluebird box project discussion and update on boxes installed. Johnson will contact DEEP to get permission to install some boxes at Silver Sands State Park where some Eastern Bluebirds were seen earlier this year. Three elementary schools are also interested in participating.
- d. Open Space Monitoring Checklist Claire Casey's students created a box for form distribution and collections. It is nicely decorated as a "Nature Walk

- Checklist". McAllister will edit the on-line form to remove the Google Map location.
- e. Application Development Checklist No updates.
- f. 701 North Street Janet reviewed her previous parcel inventory and draft open space concepts, actions, and next steps for the conservation commission. Johnson will reach out to get some estimated costs for site preparation. Johnson and McAllister will work on a draft sketch to help create a visual of what the site might look like. McAllister will ask Tom Morris and Tom Barry for some site advice as well.
