# BOARD OF FIRE COMMISSIONERS REGULAR MEETING April 21, 2009

## 6. Chief's Report

Chief LaVecchia reported on the following items:

- Peer Fitness program completed. The men will be helping the others reach fitness goals.

- I met with Regional Water Authority on March 18, 2009 to discuss insufficient water areas. I met with Regional Water Authority (RWA) again yesterday addressing water improvements needed in the area of Erna Avenue.

Chief LaVecchia said he called for mutual aid to assist with water supply needs and at the height of the fire we were flowing 5000 gallons per minute. Commissioner Stein asked about activating Code Red. Chief LaVecchia said we knew exactly what was there and no threat existed. Commissioner Stein asked when would Code Red be implemented? Discussion held regarding current Code Red package and the Chiefs recent request to the Board of Alderman for an upgrade to the current package to include unlimited minutes. Commissioner Riso added he heard nothing but good comments from all over.
