#### **Committee Reports**

#### a. Building and Grounds

Commissioner Healey stated the heat temperatures were checked and found to be good. He stated batteries were changed in the thermostats. Commissioner Healey further stated he received a call that that the tree removal was being postponed until Tuesday or Wednesday of the following week due to equipment requiring maintenance. He further stated that the stumps may not be removed until warmer weather. Commissioner Healey reported that the trap work is progressing. He stated the work is currently at 8 and 9, but weather has closed down the work for now. Commissioner Healey stated he reached out to Mallico concerning old sand piled in the parking lot. He sated Mallico will stop by to take a look and if Mallico is not interested in taking the sand he will obtain a pricing for removal.

### b. Finance

Commissioner Worroll provided a written report showing fund balances, invoices paid and funds encumbered (see attached). He discussed the transfer from the water account to repair and maintenance. Commissioner Worroll stated a further will transfer will be needed from Fund 18. He stated the budget has been prepared for the next fiscal year and remains the same, however he will be speaking with the Finance Director concerning adding another account for \$15,000 increase the budget from \$70,000 to \$85,000.

Mr. Robert McNeil provided rounds report. He stated overall a good year with rounds through December and anticipates next year to be good as well. He stated 11 bunkers have had exiting sand removed. Mr. McNeil stated drainage has been repaired in 1, 3, 4, 5 and 6 and they are ready for sand. He stated work will be starting on 8 and 9 and once completed will begin adding sand. Mr. McNeil stated this is a good time for vehicles to be on the course and the ground is frozen and the work will be completed before the season starts.

Commissioners Healey and Vecharelli made and seconded a motion to approve the 2022 meeting scheduled. Motion carried unanimously.
