Permits

- <u>18 Sailors Lane</u> John Lust, permitting agent on behalf of property owners John Gaynor and Patricia Herson. Application for a new pier 4'x100', removable ramp 3'x25' and floating dock 10'x10' along with stabilization of an eroding bank to remediate damage from Storm Sandy. Drawings were submitted along with detailed description of proposed project. The Board having no objection signed off on paperwork for application to DEP.
- <u>460 Gulf Street</u> Nancy Bennett on behalf of owner Al Berrien proposed repair of a seawall by installing hollow concrete blocks which will be put in place and then filled in place. She submitted photos of the existing property. The Board approved of project and signed off on paperwork for application to DEP.
- Oyster Landing A proposal from Carter Mario to remove center piling and add 3 piles with finger length staying the same, (slips 43 and 42 on map). B. Post said the proposal is consistent with the Harbor Plan. N. Bennett stated that there should be a solar light or reflector on the piling.

B. Kurlya added that there will be a speed reflector sign. The Board approved project and signed off on paperwork for DEP.

• B. Anderson stated that he hoped that the Board was satisfied with the fees. He asked the Board if there were any other issues that he could offer his assistance with. J. Beard stated that the Patio is of great concern to the Board and is in great need of repair. He recapped the history behind creation of Milford Landing explaining that the Marina mooring holder's fees should not and were not designed to subsidize a public park, the patio. R. Swift stated that the cost of liability insurance has increased from 2005 - \$ 10,000 to 2013 - \$45,000. They had two falls last year alone. J. Beard added that the Head of the Harbor Plan proposed more parking in Fowler Field as the Boat Ramp needs more parking. B. Anderson suggested that the Board put together something in writing as to what they propose and then work with him on getting funds to accomplish this. Also he added that all Boards and Commissions are invited to do something around the 375th Milford Celebration.
