Chairman's Report-R. Brennan

• 2020 Harbor Management Commission Proposed Dates - the dates will reflect the change to Wednesday night meetings for June, July and August and the December meeting will be the second week of the month. D. Kubek made a motion to approve the proposed dates with J. Beard seconding the motion. The motion carried unanimously.

Director's Report -R. Swift

- It has been busy fall, with Irish Fest, Octoberfest, Columbus day with higher than usual revenue and he is putting on some of the summer staff for this upcoming weekend which is looking to be pretty warm. After that will begin to wind down and get ready for upcoming winter. Keep Gerald Mezzoni through Thanksgiving to help.
- Sterling Marine provided the inspection report which shows that the Seaflex have stretched significantly and as a temporary solution to reduce float movement, he would like to shorten the limiter (safety line) restricting the slack in the Seaflex and has provided a quote for the commission review. Discussion ensued followed by a motion from R. Kirmaier to get more specific about how many need this fix and identify which ones, which we can then vote on next month. J. Beard seconded the motion and the motion carried unanimously.

Harbormaster's Report- B. Kurlya

- Attended the Port Authority meeting on October 2nd. They are searching for new executive director. As to the SHIPPS Grant there were 19 responses but there is no bonding in place yet. They will act on the grants at the November meeting with \$5 million they have to spend on small harbors, so probably will not get to it is this year. However, the Housatonic/Hammonasset has some funding leftover and he advised commission that he has put a claim on it, so we will wait and see. They may be able to get enough to cover the Seaflex project.
- Dredging will not be done on the anchorage north to the end of the channel because of the unsuitable area and it may slow down the dredging of the rest. November 1st, report the priority areas and start expediting DEEP for the permit so doesn't look good for this winter.

Deputy Harbormaster's Report - L. Henchman

- No change to availability
- All boats except 2 have been removed from the river
- Embassy cruises was referred to him by Bruce and updated them with anchorage and approach to the Housatonic.
- Boat Club got 900 cubic feet dredged at a cost of \$77,000. The New Housatonic launch area that the state put in looks great and getting lots of use.
