# MINUTES OF REGULAR MEETING HELD NOVEMBER 16, 2006

## A. CALL TO ORDER

- Vice Chairman Beard called the meeting to order at 7:30 P.M.

- C. CONSIDERATON OF MINUTES FROM OCTOBER 26, 2006 REGULAR MEETING
  - The minutes were considered. Mr. Newman moved to accept the minutes, Mr. Winters seconded the motion, the commission voted and the motion was carried unanimously.

## F. DIRECTOR'S REPORT

- Mr. Steadman has stated his fee at \$3,000 for the dredging application. Mr. Beard made a motion to accept Mr. Steadman's quote of \$3,000.00 to complete the dredging application to the DEP's Office of Long Island Sound. Mr. Zimmerman seconded. Motion was carried.
- Mr. Swift reported that dredging testing needs to be done. The Army Corps has parameters that have to be met. All agencies are required to have reports back by next Friday. The cost for testing could be up to \$7,000. \$4,000 of that is to get the samples. Mr. Zimmerman asked if dredging is for the mouth of the Harbor. Yes it is. Mr. Swift went on to report that once all the applications and testing have been approved, the commission could go ahead with dredging approximately 12,000 yards at \$15.00 per yard based on last year's soundings. Project is to dredge to 11 feet in that area. Mr. Zimmerman wanted to know what the time frame is for dredging. The plan is for it to be done by June if there are no hold-ups. Mr. Winters asked if the state would be able to help with funding. Mr. Beard stated that Jim Amann has gotten us money in the past. Also, there is some money left from the Launch Ramp project.
- Mr. Post asked about silt behind dams. Nothing has been heard about this. Mr. Beard said that this commission would have to start the move to get things going. He would like to get Mary Rose of Inland Wetlands involved on that.
