Old Business:

<u>20 Rogers Avenue</u> – Chairman Brennan explained that, Joe Wren representing owner Mr. Laydon, regarding what the Commission is willing to approve so they can make application to DEEP. Discussion Ensued. Kevin Zawoy from CT DEEP was in attendance and acknowledged that the parcel is unique and he has some flexibility and was willing to provide 30 ft. return on both North & South, however, the Commission has to be provided a plan that they can approve according to their Harbor Plan. The Commission explained that they are only going to approve a 10 ft. return on the North & South Side of the Bulkhead, there is to be no fill and the height of the new bulkhead is to remain at the existing height. The applicant is to make submission to the Planning & Zoning Department so that the application can be forwarded to all departments for review. The Commission also added that if there are any violations, they must be corrected.
