• L. Henchman and B. Kurlya attended a Harbormaster Training Session with DEEP. The Coast Guard and Homeland Security attended. Discussed DMV records are incorrect on many boats and no correction in sight, so suggestion to email DMV with correction and keep email with registration in case get pulled over. Other topics were the fees for mooring fields and emails being sent to Harbormaster for every permit applied for and more.

- B. Anderson had newspaper regarding Housatonic Project to Begin. Looking for clarification. B. Kurlya explained old project, they are fixing problems from the Bridge project, leftover items need to be removed and area cleaned up.
- Fees for Mooring Fields and Ramp were discussed and if an increase would be possible. B. Kurlya will put together list of how many residents/non residents he has. Same rate is charged for Mooring Fields regardless.
