## Chairman's Report-R. Brennan

- Met with J. Donegan to discuss moving forward with the memorial bricks
- Complaint regarding Port Milford boats exiting through the seaflexes instead of North.
- Charles Island Music Fest occurred without the Commission being made aware of it. There was no DEEP Permit taken for the barge that the bands played on and there were close to 500 boats and 100 kayakers/paddleboarders as well.
- Signage at the end of High Street for no parking have been installed. The signs have been installed on the Gulf Street Bridge, however, they still need to install the signs visible from the water for entering Gulf Pond.
- Sidewalks along Helwig Street are looking good

## Director's Report – James Donegan

- All Commercial Boat Contracts are received, and the monies deposited
- Storm did no harm at Harbor, took tent down and put back up 24 hours later
- Increased transient boaters have been coming during week
- Sent out financials to Commission on Monday explaining that final expenses are finishing up for the last fiscal year.
- Spoke with R. Brennan about the memorial bricks explaining that he has all the removed plaques from donors of trees and some names of past commission members and would like to go over the

list with someone more familiar. J. Nevin offered to work with R. Oliver to verify the names of the commissioners and Jim will get updated pricing. He has also identified an area the is currently not developed on the site which should be a good location for the Memorial Garden.

• Regarding the Seaflexes, Rich Winkepaw, was contacted about the strength of the Seaflexes with 22 lbs per band with an additional limiter providing 44,000 lbs with an 85% stretch and then the company is providing a conservative calculation assuming they are all in good condition

# Harbormaster's Report- B. Kuryla

- Port Milford boaters are not using North/South fairways. /coming out instead they are going through the Seaflexes. They need to know they are responsible for the cost to repair the damage.
- Army Core has new director Mark Cutter, 30 years with Coast Guard out of Boston and he has been notified that we are anxious for the dredging to occur
- Port Authority has a new director, John Henshaw

# Deputy Harbormaster's Report - L. Henchman

- DOT Railroad Bridge is going to be closed Sept 8 Oct 20<sup>th</sup> weekly and then again on Oct 26 Dec 7 but open on weekends and he will send out blast emails to members regarding the closures as many store their boats up a Beacon Point
- Illegal boat in mooring field and owner was contacted that they cannot sublet out the moorings.
- Followed up on No Wake Signs with Scott Allen, I found out from Audubon that the signs were made by DEEP. He will work with Stratford, partial owner of Popes Island, to get the signs made up and posted at the North and South End. Caswell Cove will pay for the signs. Discussion ensued regarding Jet Skis on the River and Boats flying through Milford Harbor.
