Report of the Investment Advisor

Mr. Beirne presented the monthly report for July, 2010 for the managers, which he reviewed with the Board.

Mr. Beirne stated that the Board received a letter from Neuberger Berman requesting that the guidelines be modified specifically the diversification section which provides that no more than 5% at the time of purchase of the portfolio will be invested in any one issue. They would like that modified to read that at time of purchase, individual issuers will not exceed either 5% or 1.5x the issuer's weighting in the Russell 1000 Growth index whichever is greater. They would also like to amend the section so that it would read that no individual security shall represent more than 10% of the total market value of the portfolio at any time. The other thing that they would like the guidelines modified so that they would read that no sector will constitute more than 1.5x the Russell 1000 Growth sector weighting, or the Russell 1000 growth sector weighting plus 1000 basis points, whichever is greater. Mr. Staneski stated that he was against this because it would allow them too much concentration in an issue. He would keep the guidelines the way they are now. Mr. Cody agreed that they should remain as is with respect to 5% in one issue.

Mr. Staneski moved that the guidelines not be changed that at time of purchase individual issuers will not exceed either 5% or 1.5x the issuer's weighting in the Russell 1000 Growth index whichever is greater. The motion was seconded by Mr. Whitaker and carried unanimously.

Mr. Staneski moved that the request that no individual security shall represent more than 10% of the total market value of the portfolio at any time be denied. The motion was seconded by Mr. Whitaker and carried unanimously.

Mr. Staneksi moved that the guidelines be modified to read that no sector will constitute more than 1.5x the Russell 1000 Growth sector weighting, or the Russell 1000 Growth sector weighting plus 1000 basis points, whichever is greater. The motion was seconded by Mr. Whitaker and carried unanimously.
