Chairman Sartor called the meeting to order at 7:40 p.m.

Disposition of Minutes:

Mr. Cody moved to accept the minutes of the September 17, 2009 meeting. The motion was seconded by Mr. Eisenhandler and carried unanimously.

Report of the Chairman - No Report

Pension Requests

(a) Victor Daniels Code 3 – Police Department

Service Connected Dis. Ret.

Calculations

Mr. Compare moved that Victor Daniels be granted a service connected disability retirement pension in the annual amount of \$56,469.86, monthly payments of \$4,705.82, retroactive to 09/18/09. The motion was seconded by Mr. Eisenhandler and carried unanimously.

(b) John J.Edmonds Code 3 – Fire Department

Non-Service Connected Dis. Ret.

Calculations

Mr. Eisenhandler moved to table the calculations of John J. Edmonds. The motion was seconded by Mr. Compare. Mr. Eisenhandler stated that due to staffing issues in the Pension Office in June and July Mr. Edmonds should have calculations redone from 7/18/09 and not 9/18/09. He stated that his application was accepted at the May meeting and the normal process time is two to three months. Mr. Cody asked if there is a substantial difference between the July and September calculations. Mr. Eisenhandler stated that there is because the calculations are based on work history and a certain amount of overtime would not be used in the calculations if the September date is used. Mr. Sartor stated that it takes at least two months to have doctor appointments scheduled and reports received.

Pension Requests, Cont'd.

Counsel for Mr. Edmonds stated that it is the duty of this Board in fairness to an applicant. Mr. Edmonds submitted his application in May and it was acted on at the May 21, 2009 meeting. There were some staff issues which led to a delay in the process. He stated that his client requested the calculations for July and he was denied those as was a Board member who also made the same request. He stated if the application was not delayed and it was acted upon in the normal course they would like to know what the calculations would be.

Mr. Sartor stated that there is a schedule of events that take place when an application is processed. He stated that on 6/5/09 releases were obtained from Mr. Edmonds to get information from his doctors. On 6/8/09 letters were sent out to his doctors requesting reports. He stated that medical reports were received on 6/25/09 and 6/26/09. A letter was sent on 6/29/09 to one of the doctors asking for clarification if Mr. Edmonds was disabled. Mr. Eisenhandler stated that a letter from an applicant's doctor is submitted with the application. Mr. Sartor stated that the Board needs to get medical reports. Ms. McKenna asked when he was asked to sign the releases and Mr. Edmonds stated that he received a message on either 6/3/09 or 6/4/09 to sign them.

Mr. Sartor stated that on 7/8/09 the doctor replied that he was permanently disabled from being a firefighter. On 7/16/09 appointments were made with two doctors and reports received on 8/5/09 and 8/13/09. The reports were presented to the Board at the September meeting.

Mr. Shea stated that there is specific contract language on how calculations are done. Mr. Eisenhandler stated that his last day of work was 9/17/09, but he was out of work

since February. The vote on the motion to table and get calculations from 7/17/09 was unanimous.
