Chm. Cody stated that the Board will need to make a recommendation to the Board of Aldermen on the pension adjustment study. He stated that Hooker & Holcombe made their presentation to the Board on the study. He stated that their recommendation is for a 2% increase with a minimum of \$120.00. Mr. Cody stated that if this is going to be the recommendation from this Board, then he would stipulate that as long as the Board of Aldermen will allocate the funds necessary to fund the increase then it would be the recommendation. If they are unwilling to do so then the recommendation would be no "cola". Mr. Murphy stated that at this time the city has not fully funded their commitment to the fund. Mr. Staneski stated that he was willing to recommend no increase. After further discussion and consideration Mr. Beckwith moved that the Pension Board recommend to the Board of Aldermen no "cola" in this three year cycle. The motion was carried 11-1 with Mr. Hedman opposed.

A motion to adjournwas made by Mr. Mahoney, seconded by Mr. Elwelland carried unanimously. The meeting was adjourned at 7:15 p.m.
