Report of Investment Advisor: Beirne Wealth

J.O. Beirne reviewed the presentations at the meeting of October 21, 2021 of potential managers, Eagle Capital Management, Columbia Dividend Value and Miller Value Partners. A discussion was had regarding the differences of the 3 companies. \$51 million of the portfolio would be divided among the 3 companies and done in 3 phases with the third phase anticipated to be by the end of 2022 first quarter.

Chairman Kimmel and Mr. Chaco made and seconded a motion to add Eagle Capital Management, Columbia Dividend Value and Miller Value Partners as managers. Motion carried unanimously.

Mr. Beirne discussed there will be a need for and potential to invest in commodities in light of the universal new green deal. He reviewed the Beirne Wealth Consulting Report for the quarter ending 9/30/21. The total portfolio for the end of September was \$433,355,739. Reviewing the Beirne Wealth Consulting report for the month ending 10/31/2021, the total portfolio increased to \$452,856,663. He reviewed the breakdown of the various funds and their values. Sprott Asset Management is being placed on watch for the next 2 quarters.
