Attached is an Application for Non-Food Itinerant Vendors in the City of Milford.

The following is a list of items you will need **plus** a \$30 Vendor Fee. On or after July 1, the vendor fee will be \$15 for the remainder of the calendar year:

A copy of your **current** Connecticut Sales and Use Tax Permit. Two (2) recent passport size photographs, black and white or color. Submit to fingerprinting (new applicants only).

#### PLEASE NOTE

### Applications require a minimum of 2 weeks to be processed.

The Itinerant Vendor License is valid from the date of issuance to December 31<sup>st</sup> of that year.

A licensee shall vend **only** during the hours of 9:00 a.m. to 10:00 p.m.

During the time such licensee is engaged in vending, the **issued Permit shall be** in the **possession** of the permitee.

Upon receipt of the application, an investigation of your business and moral character will be made as the Chief deems necessary for the protection of the public good. If, as a result of such investigation, the applicant's character or business responsibility is found to be unsatisfactory, the permit will be denied.
