Attached is an Application for Non-Food Itinerant Vendors in the City of Milford.

The following is a list of items you will need **plus** a \$30 Vendor Fee. On or after July 1, the vendor fee will be \$15 for the remainder of the calendar year:

- A copy of your **current** Connecticut Sales and Use Tax Permit.
- Two (2) recent passport size photographs, black and white or color.
- Submit to fingerprinting (new applicants only).

PLEASE NOTE

Applications require a minimum of 2 weeks to be processed.

The Itinerant Vendor License is valid from the date of issuance to December 31st **of that year.**

A licensee shall vend **only** during the hours of 9:00 a.m. to 10:00 p.m.

During the time such licensee is engaged in vending, the **issued Permit shall be** in the **possession of the permittee.**

Upon receipt of the application, an investigation of your business and moral character will be made as the Chief deems necessary for the protection of the public good. If, as a result of such investigation, the applicant's character or business responsibility is found to be unsatisfactory, the permit will be denied.
