SEC. 53A-157. FALSE STATEMENT: CLASS A MISDEAMEANOR. (a) A person is guilty of False Statement when he intentionally makes a false written statement under oath or pursuant to a form bearing notice, authorized by law, to the effect that false statements made therein are punishable, which he does not believe to be true and which statement is intended to mislead a public servant in the performance of his official function. (b) False statement is a Class A Misdemeanor. The penalty for a Class A Misdemeanor is imprisonment for a term not to exceed one year, or a fine not to exceed \$1,000 or both a fine and imprisonment. (Section 53a-28(b), 53a-36, and 53a-42.)
