DUMPSTER PLACEMENT GUIDELINES

The Milford Police Department recognizes the fact that some construction work necessitates the use of a waste disposal container for the removal of building debris. In cases of extra-ordinary circumstances or demonstrated hardship and for short-term use, a request for the placement of a waste container on the public highway may be considered by the Chief of Police on an individual basis.

How to Apply

It is important for you, the applicant, to carefully read, understand and complete the parking waiver form. It must be submitted ***14 days in advance*** of the date you are requesting the waiver. In ***Section 1***, list the required personal and business information if you are a contractor doing the actual work. Duration of the request should not exceed 14 days. Also list the purpose the container is requested for (i.e. remove fire damage debris, roof replacement, dry-wall removal, etc.).

Section 2 requires a specific description of the location you wish to place the container. A space is provided for a small diagram, if necessary. Obviously, container placement cannot interfere with sightlines of adjoining streets or driveways, or the use of fire hydrants, EMS 911 telephone boxes or public pay phones or U.S. mailboxes.

Section 3 requires the information of the carting company you have contracted with and the size of the container. The purpose of this program is to recognize and allow waste containers on the public highway when no viable alternative exists, not to minimize disposal fees. If a small container will fit on a property, it should be placed there with multiple pickups of the waste made, rather than requesting a larger container on a public street. Contractors should appropriately estimate carting costs to minimize overruns. This section also requires you to describe how the container will be readily visible to moving traffic during the dusk and evening hours.

Lastly, in ***Section 4*** explain the nature of the hardship or extraordinary circumstance that would qualify the request for approval.

Factors considerable may be natural disasters, acts of God, repair of fire damage to an occupied dwelling or a nonconforming or substandard existing land parcel supporting an existing dwelling that is being up to code.

Note: If permission is granted, the period of allowance will not exceed 14 days prior to which the need for and justification of a renewal must be submitted prior to the expiration of the prior permit. Such permission is limited to those streets under the jurisdiction of the Local Traffic Authority of the city of Milford and does not absolve the Permittee of any incumbent civil and legal obligations resultant from any tort action.

Failure to comply with the restrictions and limitations stipulated within your permit for the safety and welfare of the general public, may result in the notification of and the subsequent removal of the disposal container by the carting company you have contracted at no cost to the City of Milford, it's agencies or employees. Such failure will retract and void any earlier permission by the Police Department.
