On November 16, 2023, an officer observed a Chevy Corvette with no registration plate parked in the boat ramp parking lot on Naugatuck Avenue. The officer recognized the vehicle from many previous incidents involving the vehicle and its owner Jeffrey Yu. Yu had fled in the Chevy Corvette from the Milford Police Department on 9 previous occasions since October. Yu had 10 warrants for his arrest.

Yu fled from officers and drove over deployed stop sticks. The vehicle became disabled near 534 Oronoque Road and Yu was seen running into the wooded area. After a foot chase, Yu was apprehended. He was also found to be in possession of various narcotics and paraphernalia. Yu was taken into custody and charged accordingly. The investigation is on-going, and more charges may be forthcoming.
