The Public Hearing was called to order by Chairman Paul Austin at 7:00 p.m.

Mark Davis, Engineer, Westcott And Mapes, Inc. presented an overview of the project.

Citizens Comments:

Judith Toohey, 59 Ruth Ann Terrace – Lives in the area of construction. Wants to know how long it will take for the completion of this project. Even though it is stated that this is not a residential area, there are a lot of residential homes and it is a very high traffic area.

Raymond Macaluso of Westcott & Mapes. Inc., stated that it is anticipated to take approximately an 8 month construction period and then the pump station itself would follow suit which will take six months. Ken Bradstreet stated that this should be low impact. This will solve the odor issue that is created right now, and as Mr. Davis stated will give us redundancy should something fail then we would have that opportunity to shut the other force main down. For the traffic control, we will be working with the Fire Department, Police Department and the Board of

Education during construction. Everything will be coordinated as far as making sure that the busses for the children, life safety and the Fire Department will be in order. So, what we do is we have the pre-construction meeting prior to starting construction and the contractor has to submit a submittal for his sequence of operations which will be then approved by those departments. There will be interruption, no doubt about it, but we will try to accommodate everyone. We will also notify the residents through the Sewer Commission when this will occur. It will be an inconvenience, but we will try to avoid that as much as possible.

Chairman Paul Austin states the Public Hearing will remain open until 7:30 p.m..
