Permitting Activity August 2012

In August 2012, the City of Milford issued 114 building permits with a construction value of \$3,296,096. This does not include 194 electrical, mechanical, and plumbing permits with a construction value of \$180,292.

The majority of August construction activity was residential. Notable commercial projects included \$221,000 in renovations at Cumberland Farms at 1023 Boston Post Road and \$75,000 for renovations for State Farms insurance offices at 1 New Haven Avenue. In addition, the indoor swimming pool for LA Fitness at the Connecticut Post Mall received a permit. The work is estimated at \$75,000.

In July 2012 the City of Milford issued 85 building permits with a construction value of \$3,106,332. In June 2012 The City of Milford issued 130 building permits with a construction value of \$4,718,881.

In May 2012 The City of Milford issued 127 building permits with a construction value of \$ \$3,791,349.51. In April 2012 The City of Milford issued 128 building permits with a construction value of \$5,399,558.

Economic Activity

Total Mortgage Services based in Milford, CT was recently named to *Inc. Magazine's* 2012 *Inc.* 5000 list of America's Fastest Growing Companies for the third consecutive year.
