RESOLUTION RE: VOTING DISTRICT REAPPORTIONMENT PLAN

WHEREAS, CGS §9-169f requires that no later than June 1st in the year after the first regular General Assembly election following a reapportionment of the General Assembly, the municipal legislative body adopt a reapportionment plan based upon population data from the most recent decennial census; and

WHEREAS, according to the most recent US Census, the City of Milford had 52,495 residents in April 2020 and by dividing the census number into five (5) equal voting districts it is determined that each voting district should average 10,449 residents; and

WHEREAS, a review of the five (5) City of Milford voting districts by the Registrars of Voters revealed de minimis variances from the desired average in each district, with the largest district containing 10,457 residents and the smallest district containing 10,287 residents; and

WHEREAS, it is in the best interest of the citizens of the City of Milford to re-adopt the reapportionment plan previously approved by the Board of Aldermen on June 3, 2013.

NOW, THEREFORE, BE IT RESOLVED by the Board of Aldermen that the reapportionment plan previously approved by the Board of Aldermen on June 3, 2013 and as set forth in Chapter 2, Administration, Article 1, In General, Section 2-1, Aldermanic and Voting District of the Code of Ordinances of the City of Milford is hereby re-adopted.

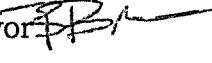
