**Consideration of minutes of August 9, 2023**

Commissioners Worroll and Healey made and seconded a motion to approve the minutes of the regular meeting held on August 9, 2023, as presented. Motion carried unanimously.

**Chairman's Report**

Chairman Amato welcomed the new appointee, R. Mayo, to fill the resignation of B. Nash. Commissioner Mayo will serve on the Golf Commission for the rest of the term until December 31, 2023, when it is time for reappointments.

**Committee Reports**

a. Building and Grounds –

Commissioner Healey shared that the quote for the ice machine has been received from Logan Refrigeration. Discussion ensued about a new model of the ice machine. Commissioner Healey also shared that the furnace has been replaced and is now ready to move forward with Onofreo's service contract. Discussion ensued about the two air conditioning units and two furnaces.

b. Financial Report.

Commissioner Worroll reported the following account balances:

Commissioner Worroll reported that everything has been submitted. He is waiting for updated invoices for the golf cart battery replacement and the tournament champion plaque. Discussion ensued about golf cart maintenance contract plans.

**Unfinished Business**

a. Ice machine:

Commissioners Healey and O'Connell made and seconded a motion to purchase the new ice machine from Logan Commercial Services for \$4,149.98.

b. Practice net: R. McNeil shared that the practice net has been ordered and will be delivered and installed within a matter of weeks.

**Management Report**

Report on Rounds – R. McNeil reported that the course is continuing to do very well with rounds. The course is up 3.7% on rounds over last year, and all numbers are trending even or upwards. Mr. McNeil shared that the course is hosting a customer appreciation day on Sunday, October 15, 2023.
