Chairman's Report-R. Post

- Two Applications for the SHIPS program have been submitted. Bob commended R. Swift, B. Kurlya, Bill Mayers and Julie Nash for their work on this grant application.
 - o Gulf St. Bridge removal, engineering \$414,000
 - Lisman Landing upgrades, to include repairs, replace the decking on the docks, electrical upgrades and floats \$430,000

B. Kurlya stated that only 14 eligible harbors and dredging is not part of this and there is approximately 7.5 million between them.

- Pond Dredging Millennium Builders was the only bid for \$2.8 million. All 4 ponds are included in the bid and the budget approved was 3.2 million. B. Anderson added that it will start at the uppermost part, Eisenhower Park, North Street, City Hall and area behind Stonebridge.
