# **Consideration of Minutes of January 21, 2016**

R. Brennan made a motion to approve the minutes of January 21, 2016 seconded by J. Nevin. The motion carried unanimously.

#### **Public Comments:**

Sharon & Paul Joslin, 7 Warren Street, Bayview, came to hear information about the dredging and the dumping site located off the beach. See Chairman's Report.

#### Chairman's Report-R. Post

R. Post stated two Oystermen submitted their comments regarding the location of the dumping site. The material being removed from the 10 ft. channel is approximately 14,000 yards of clean sandy material suitable for beach replenishment. The Army Corps Currituck is self-contained, removes the material from the channel, and dumps at the disposal site that is located between the two Points. B. Kuryla added that the cost to dump on the beach is astronomical compared to off shore dumping. R. Brennan explained the material is placed just off shore. R. Post added that this has taken over 3 years to get to this point. If the permit is delayed, the dredging will not take place this year.

- Ice Eaters are better than expected and cover a large area.
- Budget was presented to Finance Board and no issues were raised.

- House Bill 78, regarding dredging and disposal sites. It is in direct conflict with the Army Corps, Dredging Material Management Plan that has both EPA and DEEPs approvals. B. Kurlya will be attending the hearing in Hartford.
- Oyster landing DEEP issued a dredging permit, dredging window is between May 15 June 30 &September 1<sup>st</sup> January 31st
- North East Rail corridor one proposal, alternative #14 has a tunnel across the sound coming through Milford.
