- Pond Dredging Millennium Builders was the only bid for \$2.8 million and included 3-4 disposal sites, including Eisenhower Park. All 4 ponds are included in the bid and the budget approved was \$3.2 million. They will start at North Street Pond, City Hall Pond, Stonebridge Pond and lastly Eisenhower Park. Set to begin in August.
- Housatonic River Dredging Cashman was awarded the contract and scheduled for Fall.
