# January 26, 2011

- I. Mr. Gregory called the meeting to order at 8:37 a.m.
- II. Election of Chair

Mr. Gregory called for nominations. Mr. Settineri was nominated by Mr. Kapusta and seconded by Mr. Stanton. Since there were no other nominations, one ballot was cast for Mr. Settineri. Mr. Settineri assumed the Chair.

Mr. Settineri said that a company called Acoustics that had connections with the New Haven Symphony could produce a show at the Parsons Auditorium. Mr. Settineri thought that the event could be tied in with the restaurants and performers would go out after the show and play in various locations. After discussion, it was thought that it was a good idea but not for the EDC. Other groups like the MFAC would be approached to sponsor such an event.

Ms. Salvatore said that she was Chair of the Walk for Food Allergies event that had held an annual fundraiser and would like to move it to Milford. It would be held on the green in October. She has discussed the matter with the Mayor and he is supportive.

Future speakers announced by the Chair include the Mayor in February and Jocelyn Mathiasen in March. The Chair asked if Ms. Salvatore would contact the Governor about a May or June date to speak.

A drawing was held from the business cards submitted in the survey and the winner was Harriet Diamond from Composition Materials Co. Inc.

It was noted that Susan Ashelford has resigned from the Commission.
